Bicycle rental contract

- 1) Thank you for choosing the Ferrari Ski Service rental. Read the regulation below carefully and the Ferrari Ski Service staff will provide adequate assistance for the bicycle rental service.
- 2) Anyone renting a Ferrari Ski Service bicycle is responsible from the beginning to the end of the rental period. It is essential to return the intact bicycle in the same condition in which it was delivered. In other words, the rented bicycle must have the same accessories provided in the rental. If an accessory is missing, it must be paid according to the Ferrari Ski Service price list.
- 3) The bicycle rented from Ferrari Ski Service IS NOT INSURED. In the event of damage, the component, the entire damaged bicycle or the theft must be paid according to the Ferrari Ski Service price list.
- 4) The bicycle must be delivered every day by 5.30 pm in Via Funivia n°8 in Chiesa in Valmalenco. So that those who rent for several days find the bicycle always serviced and ready for use.
- 5) Ferrari Ski Service is not responsible in the event of a road accident or damage to third parties. Furthermore, the person who rents must respect the highway code.
- 6) The bicycle rented from Ferrari Ski Service is always in excellent condition and the components such as brakes, chains, sprocket packs and gearboxes are checked after each outing. The signing of the following contract by the customer affirms the excellent condition of the rented bicycle.
- 7) When the following contract is signed, the Ferrari Ski Service staff will keep the valid document or passport of every single person who rents the bicycles at the rental
- 8) Daily bike rental starts at 08:30 in the morning and closes at 17:30 in the afternoon. The rented bicycle must be returned to the Ferrari Ski Service (Via Funivia n°8 in Chiesa in Valmalenco)

PENALTY OF €10 PER BICYCLE FOR EVERY 15 MIN LATE AFTER 5.30 PM

PENALTY €10 FROM 5.30 PM TO 5.45 PM

PENALTY €20 FROM 5.45PM TO 6.00PM

PENALTY €30 FROM 6.00 PM TO 6.15 PM

PENALTY €40 FROM 6.15PM TO 6.30PM

PENALTY €50 FROM 6.30 PM TO 6.45 PM

PENALTY €60 FROM 6.45 PM TO 7.00 PM

9) Once the contract has been signed, Ferrari Ski Service staff are allowed to photocopy a credit card for each rented bicycle.

(CREDIT CARDS are required, NO BANCOMAT OR PREPAID CARDS)

Signature to accept compliance with articles 1341 and 1342 of the Italian civil code. And above all to declare having read and understood the articles of the Ferrari Ski Service bicycle rental contract: 2 (liability), 5 (damages against third parties), 3 (authorization to withdraw from the customer's credit card in case of damage or theft of bicycles), 4 (rental times) 8 (personal data)

Art. 1341. The general conditions of the contract prepared by one of the contracting parties are effective against the other, if at the moment of the conclusion of the contract he knew them or should have known them using ordinary diligence.

In any case, if they are not specifically approved in writing, the conditions they establish, in favor of, have no effect the person who prepared them, limitations of liability, the right to withdraw from the contract or to suspend its execution, or establish forfeitures, limitations on the right to raise objections, restrictions on contractual freedom against the other contracting party in relations with third parties, tacit extension or renewal of the contract, arbitration clauses or exceptions to the authority's competence indical

Art. 1342. In contracts concluded by signing forms or

forms, prepared to regulate certain contractual relationships in a uniform manner, the clauses added to the form or to the form prevail over those of the form or to the form if they are incompatible with them, even if the latter have not been deleted. The provision of the second paragraph of the previous article is also observed.
